Meeting begins 10:01am

July minutes - Erin Archer motioned to approve the minutes for July. The motion was seconded by Brooke Abitabilo and vote passed unanimously.

Brooke Abitabilo - To date, we have 114 members with a total of \$4,780.

Mrs. Thayer - We have 1,409 students, however, we expect to register more after Labor Day. Three of our Kindergarten classes are at max capacity of 27 children with an associate assisting the teacher. We've run out of rooms any more kids, we'll have to hire additional staff.

Coffee with principal will be held on September 11th at 9:00am and will include reps from district to talk about ½ cent sales tax and things that are facing St. John's County. If the sales tax passes, there will be a \$5 million expansion for LPA.

We have run out of room and basically have 3 choices: 1. Rezone 2. More portables or 3. Expansion. If we add more portables, we will have no room for fields. If we are rezoned, the furthest neighborhood away would be rezoned, which would be St. John's Golf. Our best option is expansion, which will be possible if tax increase passes. If passed, would start collecting money in January, would probably start in construction mid year 2017. Other new schools would be 2017-2018. If not passed, they will have to review because there is no plan B.

Q: Do you think there will be a lot of opposition? Probably not, problem is getting people out there to vote because it is not a presidential election year.

There used to be a need 1 new school a year, that's changed, now over the next 10 years we need to build 2 schools a year.

Kathy Brantly - we need to not tell people how to vote, but pass info along on Facebook to get the word out

Another problem is we have so many new families, October 5th deadline to register to vote, a lot of new families aren't registered some people are probably thinking no big deal because it's not a presidential year.

We decided to start a fruit grove, will start with one satsuma orange tree, see if it makes it through winter. If so, will plant more next year. We would like to get the field sprayed to get rid of fire ants

Jeanine Bawker - App sale was a bit of a dud, thinks that maybe it was confusing for parents. We sold 520 for a profit of \$6,426.53. Last year's profit off books was approximately \$16,000. Maybe Great American will listen to feedback and it will be better next year? One thing that made it hard was that this was the 1st year that great American offered this product.

Mini grants - All info is out to team leads, only 4th grade and drama have submitted their lists. We need to light a fire under them, they have a September 30th deadline.

HL - On the 23rd we're going to do a breakfast cart and give them a gentle reminder that they are due on the 30th, please let us know who was responded by then.

Erin Archer – Spirit wear is doing well, also bought pads and magnets. We've made approximately \$7,000. Just submitted an order to Jaime for about 180 items, will be filled next week. Will submit one last order on the 14th, will probably get in October.

Business partners - Traci Callaway is not here, but lots of checks have been submitted

Cynthia Dodson – Gala - DJ lined up, food lined up, still working on vendors. Still need donations, Jags tickets, beach house for auctions, memorabilia that's collecting dust, etc. really need raffle items.

They are working on graphics so Heather Lister can do flyer, wants to send out in October with \$\$ due by Thanksgiving. Biggest challenge is informing and explaining. Heather to write blurb to put on LPA website. There will be one SEC team, and either a Big 10 team, ACC or Notre Dame. Heather wants Penn State! Game will be January 2^{nd} , Saturday – kids have Monday and Tuesday off

Heather Lister - Hospitality – We go lots of people to sign up at the curriculum chats to participate in hospitality. Lots of donations of breakfast items on Friday for Room Parent Meeting.
